Homeowners who install private solar power systems or increase their capacity can apply from February 25, 2025. The 2026 budget for this initiative is €40 million, with the subsidy rate remaining stable at approximately €323 per 1 kW of installed. SolarPower Europe, the premier association for the European solar PV sector, unites 300+ organizations. Collaborating with members, SolarPower Europe shapes regulations and business landscapes for solar's growth. The aim of the cluster is to consolidate Lithuanian companies and research.
